

# Terms and Conditions

This is an agreement between **ARTSPACE-GALLERIES.COM**

## 1. Group Exhibition

The group exhibition brings together the works of 6 different artists. Each artist has the chance to exhibit up to 6 canvases (1m x 1m max).

Each show will be held for 1 week in London and for a further 2 weeks in Paris. The artist will have their work featured on ARTSPACE-GALLERIES.COM website in the buy / sell online section for 1 years to promote the artwork further. The artist can provide their own mailing list to develop a more extensive network by using the lists of all of the artists taking part.

The date of the group exhibition is to be advised by the gallery 2 months in advance. ARTSPACE-GALLERIES.COM endeavour to increase artist's profile and achieve sales by inserting artist' artwork on "on line sales" of ARTSPACE-GALLERIES.COM and placing advertisement on varies online event list sites.

Detailed information of the group exhibition on our exhibiting page remains for 5 years

- One year Buy/Sell on line included in the price
- Gallery management during the exhibition both in London and Paris
- Direct mailing to our client list
- One private view in London and one private view in Paris

Long-term Representation Agreement where the gallery intends to develop a long term relationship with an artist, can be considered and offered if the works on

display are well received and show good performance in sales during the exhibition period.

## **2. Payment**

The cost of participating ARTSPACE-GALLERIES.COM group exhibition £2,000 including full services of marketing, PR and direct mailing. Group Exhibition Participating Fees £ 2000 is to be paid immediately upon signing the contract. The Gallery promotes the exhibition and encourage the sales but the gallery can't guarantee sales.

**No sales commission applies for each item sold by ARTSPACE-GALLERIES.COM during the exhibition or afterwards.**

### **(i) Selling prices**

The artist should specify the selling prices for the work.

### **(ii) Payment to the artist**

The payment made by the sales of the artworks during the exhibition period will be paid to the artist IN FULL within 30 days after the exhibition in GBP.

## **3. Cancellation**

By signing the above contract, the artist has committed to exhibiting at ARTSPACE-GALLERIES.COM. Cancellations must be received in writing one month advance to the start of the exhibition. ARTSPACE-GALLERIES.COM will charge 1,000 £ cancellation fee to cover costs that have been made on your behalf.

## **4. Allocation of Space**

Exhibition space is allocated on a first-come, first-served basis. The exhibition floor plan is tentative and the Exhibition Manager reserves the right to adjust the floor layout.

## **5. Event/ Private View**

One Private View evening in London and Paris will be arranged with 100 £ contribution from each artists participating to cover the cost of catering and designing invitation e-flyer. The date of the Private View will be announced by ARTSPACE-GALLERIES.COM 4 weeks prior to the exhibition. Artists are encouraged to invite the list of their own guests to maximise the sales.

## **6. Ownership of Artwork**

The work remains the property of the artist during exhibitions both in London and Paris. All work will have to be delivered earliest 3 days prior to exhibition and collected latest 3 days after the exhibition. Late collection or early delivery will incur storage charge

## **7. Copyright**

The artist remains copyright owner. Any reproduction rights require the prior permission of the artist and not the artspace-galleries.com

## **8. Damages and Liability**

If a work is lost, damaged or destroyed during the currency of this agreement, ARTSPACE-GALLERIES.COM shall notify the Artist immediately and shall not be liable.

## **9. Liability, Indemnity, Transportation and Insurance**

The artist undertakes:

(i) To take out and maintain such policies of insurance against all risks as are necessary or usual or as reasonably required by ARTSPACE-GALLERIES.COM in connection with the liabilities hereunder or in respect of its properties and goods including any exhibition items brought into the gallery or in transit (including all and any of the above belonging to third parties) and the liabilities arising out of any defect or accident caused whether directly or in directly by such items;

(ii) ARTSPACE-GALLERIES.COM shall in no event be liable for any loss or damage to any artwork and items brought into or stored in the gallery by the artist. The artist shall be responsible for the security of artworks and to take out such insurances as the artist shall consider necessary and shall indemnify the company against cost,

damages and expenses incurred by the company as a result of such loss and damage.

## **10. Protection of Venue**

Exhibitors/ Artists will not deface any part of the exhibition facility. Nothing may be posted, nailed, affixed on the wall or otherwise attached to any part of the facility. Any costs arising out of negligence on the part of the artist will be the sole responsibility of the artist.

## **11. Freight / Delivery of Artworks**

All freight deliveries and shipping of artworks should be arranged by the artists. All artworks for the exhibition must be delivered to ARTSPACE-GALLERIES.COM Paris and London venues 2 days before the installation day of the exhibition. All artworks must be vacated from the exhibition venue within 2 days after dismantling of the exhibition. ARTSPACE-GALLERIES.COM will not store any artworks delivered more than 3 days earlier the start of the exhibition or the artworks stayed more than 3 days after the exhibition. Any artworks delivered earlier then 3 days or stay more than 3 days after the exhibition will be charged for storage.

## **12. Fire Regulations**

Any materials used in the exhibition areas must be non-flammable and meet local fire regulations. The local fire officer has the right to perform an on-site flame test of these materials. Use of any foreign substance, liquid or gas is subject to approval by the local fire officer.

## **13. Responsibility of the Artist**

i) For a group exhibition, we require the following:

CV / artist profile

3 images of artwork via e-mail

6 artworks – large to medium size (100x 100 cm Maximum)

The List of works consigned

Title, media, dimensions, framed/unframed

Price List

Hanging artworks will be full responsibility of the artist. With prior agreement and availability, this could be conducted by artspace-galleries.com with additional cost. Transportation of the artworks between ARTSPACE-GALLERIES.COM London and Paris Galleries are the responsibility of the artist. Use of nails and screws are prohibited on both galleries. Specifically lower ground floor galleries are tanked and use of any screws or nails is strictly prohibited.

ii) Advertising

Any advertising campaign with details of ARTSPACE-GALLERIES.COM will have to be approved by ARTSPACE-GALLERIES.COM management.

#### **14. Governing Law**

The contract between ARTSPACE-GALLERIES.COM and the artist shall in every respect be governed by English/French law, without prejudice to any right ARTSPACE-GALLERIES.COM may have to take proceedings in any part of the world the English courts, to whose jurisdiction ion the client submits by entering into a contract with the company on these terms, shall have jurisdiction in the event of any dispute arising out of or in connection with any contract made on these terms.
